The City of Waconia conducted its municipal election in conjunction with the General Election on Tuesday, November 8, 2022. The polls were open from 7:00 a.m. - 8:00 p.m. in all precincts. In addition, City Staff assisted absentee voters from September 23 through November 7. Voted ballots will be tabulated and results will be presented at the meeting. While we are awaiting final information from Carver County regarding this matter, here are a few preliminary numbers: Total Number of Voters Registered on Election Day: 8,851 Total Number of Election Day Voters: 4509 Total Number of Waconia Absentee Voters: 1551 Total Number of Waconia Voters (City Hall Absentee and In Precinct): 6060 (68.4% of all registered voters) Please note these numbers do not include mail in voters, as well as additional voters who voted in person at the County offices. I'd like to recognize the efforts of all of our Election Judges, Jersey Mikes and D'Vinci's for providing lunch and dinner, the cooperation of Faith Lutheran, Trinity School, and the Ice Arena Staff for their gracious treatment of the election officials and voters and the use of their facilities, the assistance of Public Services staff for providing delivery and set-up of election equipment, and the voters for taking the opportunity to exercise their right to vote. Last, a thank you to the City Staff and our seasonal help that participated in making absentee voting a success again this year.
